### Cooperation agreement between Institute of Humanities and Cultural studies (IHCS) and Hankuk University of Foreign Studies (HUFS), South Korea

#### Introduction:

In the context of the necessity to develop scientific cooperation between Institute of Humanities and Cultural studies from one hand and Hankuk University of Foreign Studies from the other, in the field of scientific, cultural and research relations, both Institutes acknowledge mutual benefits which result from cooperation in joint scientific projects and programs.

#### Part 1. The contents of the agreement:

1. Cooperation of both countries in implementing research plans in the field of Iranian Studies, cultural and historical relations between Iran & South Korea in the framework of cooperation between Asian cultural document center of Iran and Hankuk University of Foreign Studies in South Korea.
2. Opportunities for research for professors and students.
3. Participation in holding lectures, conferences, scientific meetings, workshops and other international or national scientific activities by mutual agreements.
4. Exchange of scientific information and providing easy access to scientific literature, including books, journals, and other scientific documents.
5. Exchange of members of staff for implementation of short and long courses.
6. Other academic cooperation based on the two institutes' agreement.
7. To determine representatives.

#### Part 2. Procedure:

8. To achieve the above-mentioned cooperation, the parties undertake to determine their fully authorized representatives immediately after completing the agreement signatures to implement its parts. Representatives are also required to continuously inform related parties of their activities and outcomes.

9. The parties may, for each of these areas and specific topics that are under the contract of the two institutions, sign and exchange separate contractual arrangement.

10. Administrative and financial obligations of each of the two parties' on issues and programs of cooperation will follow in two centers according to the agreements in executive committees and approval of the relevant authorities.

11. Any dispute or unforeseen issues in the implementation of the agreements will be negotiated by the parties.

### **Part 3. Time of implementation of the agreement**

12. This agreement will be implemented consecutive after being signed by the parties and will have the ability to run up for five years. This period will be extended automatically unless the contrary is agreed. Request for unextending must be submitted in writing at least six months beforehand. In the case of non-renewal of course, unfinished obligations of both parties should be fulfilled.

13. The same agreement may be modified or terminated by written request of the parties. The request must be in written form and at least six months before the beginning of the amendment or termination should be provided.

### **Part 4. Conclusions**

14. It is hereby certified that the present agreements is provided in four chapters, 14 articles and two copies of the authentic form and is signed by authorized representatives of both sides. This agreement is applicable from the date of the signatures of the parties.
